



## Online Tennis Court Reservation Policy

- Individual Residents may reserve courts online 8 days in advance.
- Individual Non-Residents may reserve courts 7 days in advance.
- Individuals may make a reservation **minimally 72 hours before** time of reservation if available.
- Individuals **MUST** make a reservation if playing after dusk and lights are needed.
- Courts may be reserved for a minimum of 1 hour and maximum of 1 ½ hours.
- Permittee may not book more than 1 court in a day or 3 courts in a calendar week.
- Permittee must be on-site for the entire time of rental.
- Reservation will be forfeited after 15 minutes after reservation time if permittee does not claim court.
- Reservation is for exact time listed and is intended only for tennis with the exception of pickleball with non-adhesive and non-permanent court markers. Chalk/markers are prohibited from marking the courts. No extra time will be given outside reservation time.
- Permittee must have a printed copy or electronic copy of the reservation confirmation with them on the day and time of reservation to use the court.
- Permit may not be used to teach any type of lesson even if no fee is being collected.
- Reservation requests are for individual play only. Team practices, clinics, tournaments, or league matches must be approved by the City and have a permit. - Permittee is responsible for cleaning up any litter left on court during reserved time. Please report if previous user left garbage on court to 510.675.5478 or [tennis@unioncity.org](mailto:tennis@unioncity.org)
- The reservation may not be assigned or transferred.
- Permittee is solely responsible and answerable for any damages and all accidents or injuries to persons or property resulting from their use of the courts or areas. The permittee will be held financially responsible for any damage to the courts.
- No changes, cancelations or refunds are allowed. Credits will be issued only for weather conditions or poor air quality. Permittee must notify Union City Tennis Program via voicemail @ 510.675.5478 or [tennis@unioncity.org](mailto:tennis@unioncity.org) of *any weather or poor air quality credits within 48 hours of reservation*, or credit will be forfeited.
- No refunds will be given unless there is a cancellation by City of Union City Community & Recreation Services (CRS).
- If users refuse to exit the court for permittee with proof of reservations, please call the **Union City Tennis Hotline @ 510.675.5478**. If permittee cannot reach staff @ Tennis Hotline, please call the **Non-Emergency Union City Police Department @ 510.471.1365**.
- Violations of any of the above conditions will result in suspended future reservations.
